Reference is made to the appointment of Mr. Sun Shengfeng ("**Mr. Sun**") as the other Joint Company Secretary and the waiver granted to the Company by the Stock Exchange from strict compliance with Rules 3.28 and 8.17 of the Listing Rules in relation to the eligibility of Mr. Sun to act as the Joint Company Secretary (the "**Wavier**") from the date of the Company's listing (i.e. 13 July 2016) to 12 July 2019 (the "**Wavier Period**") on the conditions that (i) Mr. Wong, who meets the requirements under Rules 3.28 and 8.17 of the Listing Rules, is engaged as a Joint Company Secretary to assist Mr. Sun in discharging his functions as a Joint Company Secretary and in gaining the relevant experience as required under Rule 3.28 of the Listing Rules; (ii) if Mr. Wong ceases to provide assistance to Mr. Sun during the Waiver Period, the Waiver will be revoked immediately; and (iii) after the end of the Waiver Period, the Company shall notify the Stock Exchange to revisit the situation. The Stock Exchange expects that at the end of the Waiver Period, the Company will be able to demonstrate that Mr. Sun would have acquired the relevant experience within the meaning of Rules 3.28 and 8.17 of the Listing Rules.

The Board is pleased to announce that Ms. Chan Yin Wah ("Ms. Chan") has been appointed as the Joint Company Secretary and the Authorized Representative in replacement of Mr. Wong with effect from 31 May 2018. The Stock Exchange has granted a new waiver to the Company from strict compliance with the requirements under Rules 3.28 and 8.17 of the Listing Rules (the "New Waiver") for a period from the date of the appointment of Ms. Chan as the Joint Company Secretary (i.e. 31 May 2018) to 12 July 2019 (the "New Waiver Period", i.e. the remaining period of three years for the Waiver Period from the date of the Company's listing on 13 July 2016) on the conditions that (i) Mr. Sun will be assisted by Ms. Chan during the New Waiver Period; (ii) after the end of the New Waiver Period, the Company will notify the Stock Exchange to revisit the situation. The Stock Exchange expects that after the end of the New Waiver Period, the Company will be able to demonstrate that Mr. Sun meets the requirements under Rules 3.28 and 8.17 of the Listing Rules, having had the benefit of Ms. Chan's assistance such that a further wavier will not be necessary; and (iii) the Company will announce details of the New Waiver, including its reasons and conditions. The New Waiver will be revoked immediately if and when Ms. Chan ceases to act as the Joint Company Secretary. In addition, the Stock Exchange may withdraw or change the New Waiver if the Company's situation changes.
